



#### **Full Contact Steel Pontoons**



# Our objective is to exceed current requirements and industry standards

- After acquiring the Moda Ingleside Energy Center, invested significant time and resources in upgrading safety and emergency response
  - Designed and installed a state-of-the-art firefighting system
  - Contracted with RTFC, the leading emergency response organization in the Corpus Christi area to ensure resources in the unlikely event of an accident
- Our terminal design exceeds National Fire Protection Association and industry standards
- We continuously explore and apply best practices and thought leadership, such as guidance from the Center for Chemical Process Safety ("CCPS")
- Our design and engineering approach elevates functionality, response capability and reliability above accepted industry guidelines governing storage facilities

# Innovative Approach to Safety and Security



## Our focus is to avoid or eliminate circumstances that lead to accidents, injuries and potential harm

#### Safety

- > Fostering a safety culture that creates a safe, healthy and sound working environment for all employees, contractors and visitors
- Developed proprietary Moda "safety app" utilized by both employees and contractors
  - Immediate notification of all incidents to highest levels of the Moda organization
  - Prompt documentation
- Established Employee Safety Committee
  - Brings common safety issues to the forefront to find timely solutions
  - Develops new initiatives and solicits new ideas to prevent injury and illness
- > Formed Safety Professionals Working Group
  - Comprised of safety professionals from all contractors
  - Discusses common issues and shares lessons learned

- Restricted vehicle access to terminal through designated parking areas to reduce risk of auto related accidents and theft

- Science and data-based Industrial Hygiene program
